





SEVERED ON JOINT PICKETING; ACTING AS STRIKERS

NEW YORK CITY, Sept. 4.—Notice was served at 6 o'clock yesterday evening on Joseph Zimovitz, president of the International Union of Marine and Shipbuilding Workers of America, and Julius Portnoy, who are both active in the picketing of the firm and five members of the union who are on strike from the New York City waterfront, for picketing the plaintiffs in any manner whatsoever, and for obstructing the business of the plaintiffs in the street near the place of business of the plaintiffs.

This is a temporary injunction, granted by Justice Aaron J. LAYTON in New York county, and it comes up for hearing on the 4th of September at 10 a. m.
