6 Chrysler Plants May Be Closed By 'Stay-in'

50,000 May Be Affected as Midland Tieup Causes Shortage

(Daily Worker Michigan Buseau) DETROIT, Mich., Dec. 1. -All departments in the six Chrysler Corporation plants in this area, employing 50,-000 workers, may shut down if a settelment is not reached by tomorrow morning in the stay-in strike of 1,200 workers at the Midland Steel Products Co.

The Chrysler Company's Plymouth assembly plant which closed down yesterday remains shut, and is not likely to open up unless an agreement is reached with the striking Midland workers.

BRIGGS OUTPUT DOWN A shortage is also reported at the Briggs Body Co. and curtailment in output has set in. Ranks of the Midland worekrs continued solid as they occupied the plant for the fifth successive

The Christian Century gives a list of reasons, good in so far as it rips the hide off the arrogance that dares to submit the interests of big capital as "public opinion." But it misses the fact that the toiling masses are politically developed and aroused way beyond 1896, when the press defeated Bryan and elected McKinley.

The N. Y. Post picks up that point and says: "The public isn't stupid. It's wise." We want every reader to paste that in his hat. The Christian Century, following Christian precepts, charges it all to the sins of the newspapers-"arrogance, tyranny, greed and scorn of fair play." But, the newspapers had those sins even in

These personal sins of the newspapers are not new. They only become more evident and more subject to mass hatred because the toiling masses are becoming awake politically and are advanc-





But it will take more than that to make the toiling masses believe that Hearst is repentant, or that the capitalist press as a whole is-or can possibly be-anything but the voice of big capital.

We emphasize this for those of our friends who, themselves admirers of the Daily Worker and Sunday Worker, in their own minds deprecate its mass appeal. Mistakenly, they think that "other people" to whom they may easily ntroduce our papers, won't like it as much as they do.

They think the capitalist press has "other people" hypnotized; when the fact is that it has these comrades hypnotized. It is a form of "Communist snobbery" and cerainly springs from a sectarian cutlcok.

Anyhow, Fordham is bound to be progressive under the presidency of a man who told an interviewer that he "hopes the fascists and the rest of the world will get back to the internationalmindedness of the Middle Ages."



Michigan's Relief Spy Scandal

· To Michigan's Black Legion has now been added another disgraceful development. It is the shameless spying by the General Motors Corp. on the Genessee County

workers on relief.

Monday's Daily Worker carried an exclusive expose of this use of the county relief authorities as labor spies. It is a shocking story. It reveals that public relief agencies are being employed by the giant motor trust for the purpose of ferreting out who are members of unions or of unemployed organizations.

Secret instructions have been handed out to relief snoopers in Flint, Pontiac and Detroit, to wheedle out of workers their union affiliations and sympathies. Those who have the courage to carry their cases to Lansing or Washington are also to be found out for

To make matters worse, when a worker applies for relief, he is asked: "Why don't you get a loan from the General Motors Corporation?" What does that mean? It is VIRTUAL PEONAGE.

On these disclosures, a question or two to Harry A. Hopkins, federal administrator of the Works Progress Administration, is in order. Does he know about this state of affairs in Genessee County and in other parts of Michigan? That is Question No. 1. Knowing about it, what will he do to clean up this scandalous mess at once? That is Question No. 2.

We look forward to a public statement, on this blocking of relief by the General Motors Corporation, from Mr. Hopkins within the week. We expect to hear that Victor Woodward, administrator of relief in Genessee County, and R. G. Harris of the Wayne County Welfare Department, have been removed and that the spy system has been wiped out. The domination of relief and other public officials by the Motor Trust requires a widespread clean-up in Michigan.

American Labor Party Should Broaden Its Base

· The executive committee of the American Labor Party has adopted a decision making ineligible for affiliation any other political party or member of another political party.

This is a wrong and unfortunate decision. It can only have the effect of narrowing down the American Labor Party and interfering with its development into a broad people's movement against reaction and fas-

The decision is, moreover, not in harmony with the statement of the preamble of the American Labor Party program:

"The formation of the American Labor Party in New York State as the permanent political instrument OF ALL LABOR AND PROGRESSIVE FORCES is an answer to the urgent need for a party rooted in the common people and giving concrete political expression to their aspirations."

It is true that the foundation of the American Labor Party and of the whole Farmer-Labor movement must be the trade unions. But the trade unions alone cannot create a party capable of defeating reaction, capable of winning the New York municipal elections in 1937. All the forces of progress-workers' political parties, farmers' organizations, Negro and middle-class groups, etc .- must be included if the American Labor Party is to become a powerful weapon of the people in this state and help build a nation-wide Farmer-Labor Party.

Nor is the vote of the Socialist and Communist Parties-about 65,000 for the Communist Party in New York City and 60,000 for the Socialist Party-to be lightly tossed aside when it is remembered that the mayoralty elections next year may be a three-

cornered fight.

Unless the American Labor Party acts without delay to broaden its organization and become a genuine people's movement, representative of all progressive forces, it will not be able to defeat the Tammany and Republican reactionaries, who may attempt to appear in the elections in various pseudo-

progressive guises. Let the American Labor Party learn from the experience of the three most successful Farmer - Labor movements in the country, the Minnesota Farmer - Labor Party, the Wisconsin Farmer-Labor Progressive Federation, and the Washington Commonwealth Federation. All of these are federated organizations and do not bar membership in other political parties.

Spain Must Be Heard at Geneva

· Rome and Berlin can no longer camouflage the fact that they are shipping troops to Spain wholesale in an effort to bolster up their ally, Butcher General Franco. Even London is becoming alarmed.

Precisely for that reason, Mussolini is frantically striving to prevent a meeting of the League of Nations Assembly, as demanded by the Spanish government, supported by the Soviet Union.

The Spanish government is demanding of the League that it act on two proposals: (1) Since the recognition of General Franco, reactionary rebel leader, by Nazi Germany and Fascist Italy is virtually aggression against Spain, it is up to the League to say and do something about this aggression. (2) The Italian and German intervention endangers the peace of the world, and the League should act to forestall such a peril

The demand should go up everywhere that the League of Nations accede to Spain's demand for a hearing.

A League of Nations Assembly meeting now would be another important obstacle in the path of the fascist war aggressors.

On this side of the water, also, concrete governmental expression to the voice of the American people is in order.

Those who stand for peace must act now to stop the fascist intervention in Spain* which is being exposed more and more as a war of German and Italian Fascism against the lawful, constitutional and democratic government of Spain.

The East Coast strike is now a COM-PLETE MARITIME STRIKE, with the exception of longshoremen in the key ports.

To this good news there have been added other encouraging developments. The French and Mexican workers have shown a solidarity with their American fellow workers that has given the greatest aid to the strikers' cause. The big ships cannot move. The first break in the shipowners' ranks has also occurred, with the granting of the best conditions in the history of the maritime industry to the seamen of three of the independent lines.

The East Coast strikers are on the verge of a fine victory. But they need aid. They need funds to carry on; they need bail money.

· The anti-Soviet serum which Hitler and Araki injected into the stream of international diplomacy seems to have brought on a world-anti-fascist rash.

How deeply the new symptoms go, indicating world resistance to the dangerous virus of the united fascist war diseases, can not be completely diagnosed now.

We present, however, some pertinent facts; Britain, whose pro-Nazi cabinet more than anyone else in

Europe inspired Hitler to forge his gigantic war machine and to dare confidently to go ahead with his war plans, is the first to feel the sting of the returning boom-Certainly the pro-Hitler men in

the Baldwin cabinet will not change their minds overnight. But they must go on the defensive because they face now a sharper struggle by their opponents within the government and parties as well as an alarmed public opinion and, per-

True, Hitler has the proclivity of making scraps of paper of any treaty. But it is beyond him to tear out of the hard-boiled minds of diplomats the facts which led up to the conclusion of the world-dividing Berlin-Tokyo treaty. Nor can he erase from public opinion the fear and warning of this fascist manifestation of aggression and world-war plotting.

Counter-moves are already maturing. Britain, France and Belgium are discussing some form of mutual assistance pact, anti-fascist in content. Belgium, thus, would be dragged back from its former overtures to Hitler and Mussolini.

Discussion of war-debt payment to the U. S. is also a financial cover to talks for joint Anglo-French-American action against the fascist world war threat. Such an overture to the United States must assure Japanese imperialism that it too has made the

biggest mistake of its rapacious history in stinging its

competitors into such costly action, Britain, during the Ethiopian war, fearful of losing its China interests, as well as its domination of the Mediterranean, came to a limited understanding with

the U.S. in the Far East. When the Ethiopian crisis passed its peak, London again began dickering with Tokyo. Since British world financial interests and American imperialist hegemony in South America clash irrevocably there is always

But the anti-Japanese informational venture agreeing to exchange "data" on Communism has changed everything in the Far East. Whether that change won't change again remains to be seen. But meanwhile London discovered that in trying to keep the reactionary balance of power in Europe it had destroyed its own balance in the Far East.

Thus Berlin is beginning to discover that its promise only to move eastward, instead of reassuring, alarms Britain because it seems that the Nazis in their enthusiasm have traveled just a bit too far eastward.

Whatever else Hitler does he must assure Japan that he keeps one European path open for attack on the U. S. S. R. That path is Czechoslovakia.

Since the new developments, reports from London and Paris say that Jugoslavia and Rumania, who were being worked on with some success by Mussolini, have since declared that a Nazi drive through Czechoslovakia would be viewed as an assault on their national safety.

The situation in Rumania, at the same time, is complicated and confused. King Carol has pledged his support to Czechoslovakia. But the powerful Iron Guard, and the majority of high army officers, look to Berlin for their guidance

However, the movement of the smaller nations concerned in Czechoslovakia's fate depend less on Hitler and Mussolini and more on London and Paris.

But the most potent resistance to the latest fascist war threat exposure can only be an aroused and united people fighting for peace, whose main weapon must be a world People's Front

QUESTIONS and ANSWERS

QUESTION-Why do the ERB workers fight against open competitive examinations? Does that not meet an attack on the merit system?

ANSWER-The ERB workers have been putting in a strong fight against the discriminatory open competitive examination ordered by the Municipal Civil Service Commission under the leadership of the A.W.P.R.A. Council of the Federation of State, County and Municipal Employes, an A. F. of L. affiliate. Their stand has been backed by the Central Trades and Labor Council and numerous other political and fraternal organizations

The basis of their demand for transfer to civil service status on taking a qualifying examination rests on the four and five years of service performed in the ERB where their merit and worth have been proved. The function of the competitive examination is to assure selection of a staff on the basis of merit and fitness and that type of staff has already been secured. To deny these workers these jobs now, after they have built an efficient relief bureau in the country and have survived four waves of layoffs, will be denying the very purpose of civil service. These 11,000 workers have been civil servants for the past few years, have passed the most stringent test-service-are highly qualified and trained, and transferring them to civil service will mean the extension of the merit system.

The Federal and state government has on numerous times in the past recognized the right of employes to be transferred to civil service, after they have worked on a job and proved their worth. The fight for the extension of civil service has not meant wholesale dismissal and imposition of discriminatory examinations on jobs placed under civil service, but transfer of these workers into civil service, when their merit and fitness has been unquestioned. Teachers, transit workers, and the workers in the Milk Control Board were all treated in this fashion. This present action against the ERB workers is undoubtedly aimed against the union, and can only be considered a union-smashing attempt.



Child Labor Increases in U. S. As Orgy of Profits Continues

Production is normal—\$4,000,000,-000 in dividends. Cheers! But after the red hot night of celebration over nearly four billion dollar dividends this year, comes the cold gray morning of sobriety

to the capitalists of America. Suppose all this display of wealth stirs envious feelings in the wagecut, speeded, slave-driven workers? Suppose it rouses resentment in the unemployed, half of whom are al-ready told they are going to be kicked off relief or WPA projects? Already the steel workers express dissatisfaction with their 10

per cent sop. Already the United Textile Workers have demanded a 20 per cent raise, instead of the 5 and 10 per cent raises and bonuses that were intended to keep them quiet.

MILLIONS STILL JOBLESS

Already people draw comparisons between four billion for stockholders and \$155,000,000 in promised, in most cases only promised, wage raises and bonuses this year.

So here comes the United States Labor Department Bureau of Labor Statistics with assurances that 'business is back to normal" in most industries, that "employment is back to normal," that payrolls are "back to normal" this October. Crisis is over-but there are

millions jobless! On the face of it it seems queersince WPA Administrator Harry L. Hopkins has just admitted there are between eight and eleven million unemployed-and even the hopeful Hopkins sees no way to avoid at least seven million unemployed next year.

We're normal, child slavery has doubled.

It seems astonishing, too, that with all these unemployed adults, the National Child Labor Committee would have to raise the alarm, as it did this week, over a doubling of the number of child slaves since "recovery" and the period of "normalcy" began. Adults grow sick at heart and empty of stomach as they frantically tread the highways and ride the freights, looking for jobs, their only gain from the WPA period being the cute little pink slip discharge paper. But children, perhaps their own children, toil up to fourteen hours a day in the beet fields, for 90 cents a day, up twelve hours a day logging in Southern sand swamps for ten cents an hour, as long as there is daylight in the cotton wick bed spread industry f r as low as eleven cents a day.

CHILD SLAVERY

If the jobless worker feels upset about this, he can console himself that it is strictly legal. WPA is putting through no rule that "no parent is to get relief work if his

son or daughter has private employment.' Workers wanted-Age 14!

Steel and iron and their products, according to the statistics just released this week through the Labor Department's Bureau of Labor Statistics, show employment 97.6 per cent of what it was in the period

of 1923-25. All these most recent government figures are percentages of the 1923-25 levels. Why? Can it be because this also was a low production period, including the short but severe crisis of 1924? Most people have forgotten 1924. Why didn't they compare with the period of 1928-29, when production was

much higher? MORE HOURS, LESS PAY

But anyway, let that go now and look at the figures about which the Labor Department is so reassuring. Payrolls are only 92.8 in the iron and steel industry, where employment is now 97.6 per cent.

Just normal wage cuts. That means, workers are nutting in more hours for less pay than they got in 1923-25. And this runs

all the way through Manufacture of machinery shows employment at 109.9 and payrolls

Transportation equipment manufacture shows employment at 101.8 and payrolls 95.8. Non-ferrous metals and their products, employment 108.2 and

wages 99.4. Textiles, and their products, 104.2 employment, and 88.4 payrolls. Notice how very much lower wages are in this industry.

Food and food products, employment 123.9 and payrolls 111.2. Chemicals and petroleum, employment 120.4 and payrolls 114.5.

WAGES LAG BEHIND

The labor department's latest figures are only for manufacture; if they had included services too, then they would show a shocking decrease in the number of railroad workers employed.

Now there you have the real story. the favored industries, over which the Labor Department crows, things are bad enough. Employ ment is not up to the pre-crisis level, in those particular industries it is up to the 1923-25 period. Wages, with few exceptions, lag far, far be-

And in industry in general, outside the charmed circle of mainly war industries - steel, chemicals, achinery, etc., employment is nowhere near even the 1923-25 level. And here, too, wages are far below the level even of employment.

How does one explain then the enormous profits this year?

Ask the worker in the plant who does have a job-he knows. Rationalization, speed-up, driving in all its forms-give the answer. Industry is producing at a high level, enough to make super-profits. But the employed worker gets less pay, and the eight to eleven million jobless are not taking part in it. They are permanently squeezed out of in-dustry because of the long hours and the speed up.

STOP WPA SLASHES Capitalism, and its capitalist gov-

ernment, has no future use for these jobless, and proposes to stop feeding them. That is the whole idea back of the WPA slashes. This must not be allowed to go

Employed and unemployed workers must act as a unit in this fight. Raising wages and cutting down the hours of work will help take

care of part of the jobless For the others, WPA must be enlarged, not cut down, and since it has to be a permanent factor in the future, for permanently unemployed millions, wages in WPA must be raised. The project workers must not be allowed to remain a class of

underpaid outcasts. And on top of that, a strenuous battle is needed to change the totalinadequate National Security Act into a real unemployment and old age law, with no payroll taxes on the workers and adequate payments. That is, demand that Congress pass the Frazier-Lundeen Social and Unemployment Insurance Bill

Their Best Chefs For Soup Kitchen

The Striking Seamen Claim That the Soup Kitchen Set Up By Ted Lewis Is the Best One They've Ever Been In: the Y. C. L. Helps to Keep the Pickets Warm

You go through a hallway that might be a passage to China, it's so long and dark. The Soup Kitchen for striking seamen is at the end of the hall, one flight up, over at 338 West 25th Street.

The place was filled with men when I got there. They say it's filled most of the time. The kitchen has been feeding between sixteen and seventeen hundred men a day and now they've got new customers for they've arranged to feed the masters, mates and pilots and engineers.

There was a radio making a racket and the seamen sitting along do you recommend for this disthe wooden benches eating stew and bread were laughing and talking. A couple of them said to tell the Daily Worker readers that this was the best soup kitchen they'd evere

It's open twenty-four hours straight and there's a staff of ninetysix fellows split into six watches. Ted Lewis, who is the seaman in charge, said the best chefs and stewards from the big ocean liners were the cooks and help in the Soup Kitchen. He said you don't need to worry about the cooking that goes on here, it's the best. What worries him and the others is the shortage of things to cook.

A Real

You'd know Lewis for a sailor the minute you laid eyes on him. He's laughing and carefree most of the but he's also dead serious about his responsibility, and effi-Two weeks ago when they were trying to set up the Soup Kitchen he tramped all the streets near the waterfront, looking for a loft they could rent. The owners of many buildings had given orders not to rent to the strikers. Others jerked the rent so high the seamen couldn't even look inside.

Lewis was telling me about Ferdinand Smith, a member of the Strike Committee who is in charge of the whole food committee and the four soup kitchens that are in Manhattan and Brooklyn. He says Smith is one of the best fellows he ever worked with. The strikers have been getting a lot of support from Harlem. Smith, who is a Ne-gro leader, works tirelessly to activize everybody up there in the interest of the strike.

The women are helping out a lot the seamen up at the kitchen said enthusiastically. The Women's Citizens Committee, for instance, brings in a large number of the donations upon which the kitchen is run.

The strikers come in with a meal ticket they get over at headquarters. They come in for meals three times a day and those on picket duty at night get coffee served to down on the line. It's the Y.C.L. that is carrying on this part of the good work. The Y.C.L. car-ries the coffee to the pickets between eight p. m. and six in the morning. They bring their own trucks and pick up the coffee at the Soup Kitchen. The seamen said the YCL'ers were pretty swell. the picket line along about four in morning and some kids come to you with hot coffee-hell, that's the best thing you ever tasted in your life.

This is most economically done with brewer's yeast, which contains large quantities of the vitamin. (More expensive, widely advertised forms of yeast are no more effective than the ordinary dried brewer's yeast in powdered form. Yeast in tablet form may be more palatable and easier to take.) Recently an announcement was made that vitamin B1 has been prepared synthetically, but this product (to be given by injection) is not yet available for general distribution.

It should be emphasized that the treatment must be carried out under the direction of a physician.


