CONVICT ADMITS HE TALKED TO FOELKER

But Denies Offering Senator Money for His Vote—Hansen's Name Brought In.

OSSENING, N. Y., Oct. 21.—Convict Schroeder, former quarantine commissioner, denied to the legislative graft committee, which questioned him here today, that he had offered Senator Foelker money for his vote on the racing bill, but admitted to talking to Foelker about it.

"On Sunday, I don't know the date," began Schroeder, "I was called to the phone and Senator Hasenflug wanted to speak to me. He said, 'Fred, what is the matter with that damn Senator of yours? Some says he will vote against the bill and some says he will vote for it. We need his vote and I wish you would try to get it.' I said I would."

"The next Monday I asked Mr. Foelker to meet me at my office and told him his vote was wanted very badly. I told him if he had any political aspirations it would kill them to vote for the bill. He said he would talk to Al Hobbey about it. I told Hasenflug and advised him to see Hobbey about it."

Hobbey is the Brooklyn ex-sheriff and candidate for Congress, who has the endorsement of the Hearst party.

"That is the only time I spoke to Foelker about the race track bill," he continued, "There was nothing said about \$45,000 or \$50,000. I believe I had heard there was a fund of \$1,000,000 or \$500,000."

"Was there anything said by Mr. Hasenflug that made you believe you were to sound Foelker and see if he was in a receptive attitude?"

"I presumed they were after him with money, but Hasenflug never said anything about money, never suggested it."

"You told him that it would kill his aspirations if he voted for the bill, but that if he wanted to vote against it he could make his own arrangements with those who were opposed to the bill?"

"Now, governor, let me tell you something. I don't know as it was necessary to mention the money. I thought if he wanted to vote against the bill he would take advantage of it."

"No, he never said anything of the kind to me."

UNION LABOR MEETS WITH LEGAL DEFEAT Judge Richardson Decees That Favoring Union Makes Municipal Contract Void.

(Special to The Call.) BOSTON, Oct. 20.—Union labor met another defeat yesterday when Judge Richardson, in the Superior Court, decreed that municipal corporations must not favor organized bodies of union men.

The case in question was one in which the city of Boston let a contract to the Dolan Electrical Company to furnish electrical appliances for Curtis Hall, in Jamaica Plain.

The Dolan company's bid was \$4,417, \$2 higher than that of the James Wilkinson company, which brought a suit, through twelve taxpayers, to have the city restrained from giving the contract to Dolan.
