Milk Strike Is Concentrated on Large Dairies

STRIKE IN SMALL PLACES IS CALLED OFF

LOS ANGELES, Jan. 26.—The Milk Section of the Food Workers Industrial Union, at their regular meeting last night, voted to concentrate on Adohr, Golden State and Jessup dairies and call off the strike in all the other smaller dairies.

This move will make it possible to support the strikers in the large dairies, which have fought the strike with every form of police and gang terror and lying newspaper propaganda.

The other dairies have already begun calling the union to send out strikers. They have been caught between the pressure of their dairies, which have been fighting on as milk price was in order to force them out of business and yet have insisted that they hold out against the union and the workers who have insisted on union recognition.

Milk is selling as low as 5¢ a quart in Los Angeles.

Supervisor Jessup, large dairy owner, has asked the A. F. of L. to organize a "legitimate" union of the milkers to fight the militant TUUL union.

Fakers Fail in Try to Split Gallup Miners

MINERS REFUSE TO JOIN THE U.M.W.A.; 75% ORGANIZED IN MILITANT UNION

GALLUP, N. M., Jan. 24.—Two attempts of the fakers Bill Reed, boss Moses Starn and Telly Tully to split the miners held by building local of the A. F. of L. United Mine Workers of America failed recently.

At the first meeting, called in the Gamarco (Gallup American Coal Co.) camp, Jan. 20th, about thirty showed up. Starn and Tully proposed that they change the name from the U.M.W.A. but this was voted down, some declaring the miners would not join the U.M.W.A. under any name. Moses, mine superintendent, proposed an independent union, but a miner said they were all satisfied with the militant National Miners Union and did not need two unions. The meeting was quickly adjourned.

The next meeting was called last Friday, after the U.M.W.A. group passed around, the word that a mass meeting would be held to call a strike on Monday. On Friday night, the regular meeting of the NMU Gamarco local voted to attend the fakers meeting, in the meantime by a leaflet warning the miners against the attempt of the U.M.W.A. to split their ranks and try to gain control of the pits and force the check-off system upon them.

Walk Out of Meeting

Starn opened the meeting, saying all those who did not want to join the U.M.W.A. must leave. Most of the meeting got up and walked out, including a member of the U.M.W.A. committee who resented this forcing the miners to leave the mass meeting. Only about forty were left in the hall, and they were company men, gunmen, store clerks, etc. with a few from camps outside Gamarco.

After the miners left, those remaining voted a strict no-strike policy, and to abide 100% by the NRA—an interpretation by the Gamarco.

More than 75% of the miners are in the National Miners Union, affiliated with the TUUL whose leadership won in their last strike and have no use for John Lewis' no-strike agreements.

Chambers Faces a New Visalia Frame-Up Trial; Rush Protests!

VISALIA, Cal., Jan. 29.—The trial of Pat Chambers, district organizer of the Cannery & Agricultural Workers Industrial Union, on framed-up charges of criminal syndicalism for activity in the October cotton strike, will begin here Feb. 6.

In the first trial, held in December, so flimsy was the frame-up that six of the jury voted for his acquittal.

Chambers, together with Stanley Hancock and Dorothy Ray is at present in jail in Imperial Valley.

ORANGE STRIKE IS CALLED OFF; GAINS SCORED

UNITY OF RANK AND FILE IN THREE UNIONS IS KEPT DESPITE MISLEADERS

LOS ANGELES, Cal., Jan. 24.—The strike of 550 orange pickers in San Bernardino, Riverside and Los Angeles counties was called off Monday night by the Cannery & Agricultural Workers Industrial Union, with an increase in 1½¢ a box pay for the pickers over the 4¢ a box previously paid.

Where usually 5000 pickers work in the orchards in this vicinity, this year the peak was 2500. Pay was so low, experienced pickers hardly averaged 50¢ a box.

When the strike was called, the members of the Mexican Confederation of Labor voted to form a united front with the C. & AWU, and remained true to their decision throughout the strike, picketing alongside the Industrial Union members, and braving with them, the organized police terror whenever it was necessary to hold union meetings or distribute leaflets and bulletins.

Although the A. F. of L. union took no action in the strike, the pickers in that union refused to scab. Many of them joined the C. & AWU during the strike. In Redlands A. F. of L. misleaders tried, and failed, in efforts to break the strike, while terror was organized against the strikers. More than 400 paid deputies were used in the fields.

Realizing the failure to make larger gains was due to insufficient organization, the union is organizing stronger for future struggles.

The trial requested the Klamath County district attorney to file a brief in the case, in answer to the appeal of the I. L. D. attorneys.

Convicted purely on repudiated confessions forced from him by brutal third-degree methods, Jordan's position is no less dangerous now, as the move for a prosecution brief is seen only as getting a legal basis on which to deviate the appeal.

2,000 at Brawley Agricultural Union Meet

L. D. TO DEFEND THE 80 ARRESTED DURING STRIKE

LOS ANGELES, Jan. 25.—Wirin, attorney for the American Civil Liberties Union, recently kidnapped by an armed gang in Brawley during the lettuce pickers strike, has returned to Los Angeles to prepare his case against Captain Hynes, Capt. of the State Highway Patrol in Imperial Valley, Governor Ralph, and twenty-five "John Does" for conspiracy to break the Cannery & Agricultural Workers strike by terrorism, violence and lawlessness. He is suing these three and others for \$250,000 damages.

Twenty dozen others kidnapped

Wirin from the plateau the night before carried him out into the desert, beat him and left him there threatening death if he didn't leave the valley.

They had hoped, by this means to stop the Azteca Hall meeting for which the A. C. L. U. had pronounced a Federal injunction against Sheriff Campbell and Chief of Police Cromer to prevent its being broken up. However, 2000 agricultural worker waited quietly for an hour for Wirin to appear, and when it was clear he would not be present, other speakers took the floor and the meeting was carried on.

When Wirin was located in El Centro later that night, where an armed drunken mob of deputies and Legionnaires forced them all into automobiles and with police escort they and Wirin were driven out of Imperial county.

I. L. D. Defending Jailed Strikers

With all the efforts of the International Labor Defense at work defending the 80 strikers who had been arrested in the reign of terror, a joint conference of the I. L. D., Trade Union Unity League, Pen and Hammer and others decided the A. C. L. U. should fight in the valley for the right of the workers to meet, while the other organizations supported the strike.

Cordage Co. Men Strike and Win

ORANGE, Cal., Jan. 23.—One hundred and twenty workers at the Great Western Cordage Co. went on strike here last Monday and within fifteen minutes had won an increase of 20¢ and returned to work.

The workers had organized into a union, but when the membership had grown to forty a long dormant committee stepped in and influenced the membership not to join the Trade Union Unity League.

As a result of the strike the workers who started the union are showing the results of organizing and are continuing the struggle to affiliate the union with the TUUL.

Preparedness Parades Again

We Communists are particularly in any movement for the defense and uniting of the nation as a whole but particularly of the shares of our greatest communists. — Ralph.

As a Pacific Ocean frontier, the citizens of San Francisco have been alert to the dangers of inadequate preparedness.

Such are the expressions of the capitalist political leaders on the coast as they launch "Defense Week" to whip up a pretentiousness hysteria. The main purpose of the parades above show is to distract us as this ballot is armed camp, since the next war will be on the Pacific.

Saturday, the 17th will be marked by a grand display of arms and military, and jingo oratory bringing to mind the 1916 "Preparedness Parade". The \$11,300,000 battalion "San Francisco" launching is part of the drive.

The most striking feature is the intense agitation campaign directed with a pacifist appeal—for the sake of maintaining peace. This is also the object in the showing of the horror war pictures. We all told that we do not want to be the victim. Consequently, those who are not prepared to defend ourselves. Consequently, there should be no objection over one billion and one hundred million dollars being appropriated for armaments, while millions go hungry. Pacifists who do not see war as a result of the capitalist system, but merely condemn it as inhuman, horrible, or merely a misunderstanding, easily fall into this trap of the war makers, and give their wholehearted support for militarization. It is such logic that leads to even supporting a war "to end all wars" or "to save democracy"—the excuse given for the last war.

PACIFIST DANGEROUS IDEOLOGY

This is precisely the reason that the Communists regard pacifism as the most dangerous ideology. It builds up in the minds of the people confidence in the capitalist peace promises, and disarmament conferences. Now when war is very near, and the imperialist powers have dropped even the farcical disarmament conferences, pacifism adapts its ideology to justify armament as the only guarantee for peace. Pacifists are opposed to a militant struggle against war, through such measures as stopping armament, cutting down army or navy organization, and instituting a non-war winning over army or navy men to the side of the workers, etc. Confusing their anti-war work to merely advocating "love for peace" only delays those organizational measures that must be taken for an effective fight against war. At the bottom, pacifist leaders are patriots and supporters of capitalism, and as we have witnessed during the last war, in most cases they were the loudest in all jingo campaigns, and used effectively to whip up patriotism.

The fact that pacifists are already lining up with the war mongers should be the most convincing proof that war is near. — TO EXPAND STEEL PLANTS

Coincident with preparedness parades, is the visit to the coast of W. A. Irvin, president of the U. S. Steel Corporation, who announces that several million dollars will be spent to increase the capacity of the Torrance and Pittsburgh steel plants in California. This at a time when the steel plants in the east have been operating at less than 35% of capacity. What other reason is there than the need to expand industry on the coast? Certainly we can well believe that there is basis for such expansion on the basis of California's domestic needs.

The capitalist call for preparedness must be countered by the workers' call to prepare—but to fight war, and increasing armament. It must stir us to much more intense organization work, thus far completely neglected; to organize fighting rank and file unions in the steel plants of Alameda, Contra Costa, and other parts; in the shipyards such as Mare Island, Union Iron Works and Moore's in the oil fields around Bakersfield and Long Beach; on the docks and ships through which materials are transported; and in all war industries.

But there is only one trade union movement that fights war, that which is under the leadership of the Trade Union Unity League. JOIN IT!
